FORMULATION

Pieces of French oak (cubes), from selected species *Quercus robur* and *Quercus sessiliflora*, sourced only from French forests. These forests are naturally grown without any treatment products. Woods are naturally air-seasoned 24 months minimum before transformation. No chemicals are used during the stage of transformation or storage. Once seasoned, oak is machined to transform in sticks, then toasted with a convection oven, at light level (**HIGHLIGHT**), average level (**MEDIUM**), or heavy level (**MEDIUM+**) and then cut into cubes.

FIELD OF APPLICATION

Use on white, rosés and red wines, during alcoholic fermentation or ageing.

Enological product, whose utilization is controlled according to the regulation. Refer the legislation in force in your area.

APPLICATION RATE

White and rosé wines: 1 to 3 g/L. Red wines: 2 to 6 g/L. Application rate must be adapted to the organoleptic objective.

DIRECTIONS FOR USE

Use by soaking the cubes in the wine on tank. Infusion bags permit an easy introduction and remove.
