Therefore typical Food Safety Standards are not directly applicable to a filter manufacturer such as Amazon Filters, but specific parts of Amazon Filters Quality System can help a food manufacturer comply with such standards.

### **Amazon Filters Manufacturing and Traceability Systems**

Amazon Filters products are manufactured in a facility and using processes that have been regularly audited and have been shown to be in compliance with current GMP requirements for suppliers of disposable product contact items to the pharmaceutical and food industries as laid down by the US Food and Drugs Administration (FDA) (specifically with the relevant parts within 21CFR), the European Medicines Agency (EMA) and the Food Regulations relating to the European Community.

Manufacturing Lots are well defined and manufactured by following detailed Work Instructions and Quality Plans, thus ensuring that the highest quality and traceability standards are consistently maintained.

As part of Amazon Filters' Quality Assurance System, accredited to BS EN ISO 9001:2015, full product traceability is assured, from raw materials to receiving users.

In addition, Amazon Filters purchases its raw materials from approved suppliers. Amazon issues a detailed Purchase Specification to its suppliers to ensure that the form, fit or function cannot be altered without notification to Amazon Filters.
